# Structural properties of positive real and reciprocal rational matrices 

Thomas Berger and Timo Reis


#### Abstract

We consider positive real rational matrix-valued rational functions. We show that the pointwise kernel of functions as well as the pointwise kernel of the Hermitian part is constant in the right complex half plane. These results are the basis for a decomposition for positive real matrices under orthogonal similarity transformation. We further consider positive real matrices which have a certain symmetry property that is known as "reciprocity". A decomposition for reciprocal and positive real matrices under block orthogonal transformation is derived.

We illustrate our results by applying them to transfer functions arising in electrical circuit theory. Index Terms-Passivity, positive realness, reciprocity, transfer function, electrical circuit, modified nodal analysis.

Note that we neglect the subscripts in the case where the sizes of the identity and zero matrices are clear from context.

## I. Introduction

We study positive real rational matrix functions $G(s) \in$ $\mathbb{R}(s)^{m, m}$, that is
a) $G(s)$ does not have poles in $\mathbb{C}_{+}$, and
b) $G(\lambda)+G(\lambda)^{*} \geq 0 \quad \forall \lambda \in \mathbb{C}_{+}$.

This class of rational matrices plays an important role in linear systems theory, since they are transfer functions of passive linear time-invariant systems [1]. In particular, they are important for the analysis and synthesis of electrical circuits and mechanical systems, see [2]-[4] and the references therein.

[^0]Another crucial concept studied in the present article is reciprocity. Loosely speaking, this is the property of a transfer function to satisfy a certain symmetry property.

Definition 1.1 (Signature matrix, reciprocal matrix): Let $m_{1}, m_{2}, m \in \mathbb{N}_{0}$ be such that $m_{1}+m_{2}=m$. Then

S=\operatorname{diag}\left(I_{m_{1}},-I_{m_{2}}\right) \in \mathbf{G l}_{m}(\mathbb{R}) \tag{1}
\end{equation*}
$$

is called a signature matrix.
A rational function $G(s) \in \mathbb{R}(s)^{m, m}$ is called reciprocal (with signature ( $m_{1}, m_{2}$ ), if for $S$ as in (1) it holds

$$
G(s) S=S G(s)^{\top} .
$$

Reciprocity means that the transfer function can be partitioned as

$$
G(s)=\left[\begin{array}{cc}
G_{11}(s) & G_{12}(s)  \tag{2}\\
-G_{12}(s)^{\top} & G_{22}(s)
\end{array}\right]
$$

where $G_{11}(s) \in \mathbb{R}(s)^{m_{1}, m_{1}}, G_{22}(s) \in \mathbb{R}(s)^{m_{2}, m_{2}}$ are symmetric. This class of rational matrices occurs in electrical circuit theory, where the signature is determined by the numbers of voltage and current sources [1], [2], [5].

In Section II we focus on positive real matrices. We show that $\operatorname{ker} G(\lambda)+G(\lambda)^{*}$ is independent of $\lambda \in \mathbb{C}_{+}$. We further prove that $G(s) v$ is constant for all $v \in \operatorname{ker} G(\lambda)+G(\lambda)^{*}$. Upon these facts we derive a decomposition for positive real matrices under orthogonal similarity transformation. This form decomposes $G(s)$ into a part which has a positive definite Hermitian part in $\mathbb{C}_{+}$, and some constant skewHermitian part.

Reciprocal matrices are then investigated in Section III and another decomposition is derived for positive real and reciprocal rational matrices under similarity transformation with block-diagonal orthogonal matrices.

Finally, in Section IV passive electrical circuits modeled as differential-algebraic systems. The transfer functions of these systems is positive real and reciprocal and hence we may derive some consequences of the results from the previous sections.

## II. Positive real transfer functions

In this section we investigate positive real matrices and derive a decomposition under constant orthogonal transformations. First, we need the standard representation of positive real matrices. To this end, recall that $G(s) \in \mathbb{R}(s)^{m, m}$ is called proper, if $\lim _{\lambda \rightarrow \infty} G(\lambda) \in \mathbb{R}^{m, m}$ exists; $G(s)$ is called strictly proper, if $\lim _{\lambda \rightarrow \infty} G(\lambda)=0$.

Lemma 2.1 (Positive real functions [6, Sec. 2.7]): Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real. Then $G(s)$ has no poles in
$\mathbb{C}_{+}$. Furthermore, $G(s)$ has a representation

$$
\begin{equation*}
G(s)=G_{s}(s)+M_{0}+s M_{1}+\frac{R_{0}}{s}+\sum_{j=1}^{k} \frac{R_{k}}{s-i \omega_{j}}+\frac{\overline{R_{k}}}{s+i \omega_{j}} \tag{3}
\end{equation*}
$$

where

- $k \in \mathbb{N}$,
- $\omega_{1}, \ldots, \omega_{k} \in \mathbb{R}$,
- $R_{1}, \ldots, R_{k} \in \mathbb{C}^{m, m}$ are Hermitian and positive semidefinite,
- $R_{0}, M_{1} \in \mathbb{R}^{m, m}$ are symmetric and positive semi-definite,
- $M_{0} \in \mathbb{R}^{m, m}$ such that $M_{0}+M_{0}^{\top}$ is positive semi-definite,
- $G_{s}(s) \in \mathbb{R}(s)^{m, m}$ is strictly proper.

Furthermore, the proper transfer function $M_{0}+G_{s}(s) \in$ $\mathbb{R}(s)^{m, m}$ is positive real.
We show that, for a positive real matrix $G(s) \in \mathbb{R}(s)^{m, m}$ and $\mu, \lambda \in \mathbb{C}_{+}$, the kernels of $G(\lambda)+G(\lambda)^{*}$ and $G(\mu)+$ $G(\mu)^{*}$ coincide. We will conclude that the kernel of $G(s)$ is constant.

Proposition 2.2: Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real and $\lambda \in \mathbb{C}_{+}, u \in \mathbb{C}^{m}$ be such that $u^{*} G(\lambda) u=0$. Then $u^{*} G(s) u=$ $0 \in \mathbb{R}(s)$. Furthermore, $G(s) u$ is constant.

Proof: Consider the scalar rational function $g(s)=$ $u^{*} G(s) u \in \mathbb{R}(s)$. Then $g(\lambda)=0$ and, moreover, $g(s)$ is positive real. Assuming that $g(s) \neq 0$ gives that $1 / g(s)$ is again positive real, cf. [7]. However, this contradicts the fact that $1 / g(s)$ has a pole at $\lambda \in \mathbb{C}_{+}$. As a consequence, $g(s)=0$, i.e., $u^{*} G(\mu) u=0$ for all $\mu \in \mathbb{C}_{+}$. Thus, for all $\mu \in \mathbb{C}_{+}$, we have

$$
u^{*}\left(G(\mu)^{*}+G(\mu)\right) u=(G(\mu) u)^{*} u+u^{*}(G(\mu) u)=0 .
$$

Since $G(\mu)^{*}+G(\mu)$ is positive semi-definite, we find $\left(G(\mu)^{*}+G(\mu)\right) u=0$, which is equivalent to

$$
G(\mu)^{*} u=-G(\mu) u \quad \text { for all } \mu \in \mathbb{C}_{+}
$$

As a consequence, the entries of $G(\cdot) u: \mathbb{C}_{+} \rightarrow \mathbb{C}$ are holomorphic and their complex conjugates are holomorphic as well. The Cauchy-Riemann equations [8, pp. 231] now imply that $G(s) u$ is constant.

We may immediately conclude that the kernel of a positive real function is constant.

Corollary 2.3: Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real and $\lambda \in \mathbb{C}_{+}, u \in \mathbb{C}^{m}$ be such that $G(\lambda) u=0$. Then $G(s) u=$ $0 \in \mathbb{R}(s)^{m}$.

We now show that, via a similarity transformation with an orthogonal matrix, any positive real rational transfer function may be decomposed into a part which has positive definite Hermitian part in $\mathbb{C}_{+}$, and some constant skewsymmetric part.
Theorem 2.4: Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real. Then there exist numbers and matrices

- $p \in\{0, \ldots, m\}$,
- orthogonal $U \in \mathbb{R}^{m, m}$,
- positive real $G_{1}(s) \in \mathbb{R}(s)^{p, p}$ with $\operatorname{ker} G_{1}(\lambda)+G_{1}(\lambda)^{*}=$
$\{0\}$ for all $\lambda \in \mathbb{C}_{+}$,
- $L_{12} \in \mathbb{R}^{p, m-p}$,
- skew-symmetric matrix $L_{22} \in \mathbb{R}^{m-p, m-p}$,
such that

$$
U^{\top} G(s) U=\left[\begin{array}{cc}
G_{1}(s) & L_{12}  \tag{4}\\
-L_{12}^{\top} & L_{22}
\end{array}\right] .
$$

Furthermore, we have

$$
\forall \lambda \in \mathbb{C}_{+}: \operatorname{ker} G(\lambda)=U \cdot\left(\{0\}^{p} \times \operatorname{ker}\left[\begin{array}{l}
L_{12}  \tag{5}\\
L_{22}
\end{array}\right]\right) .
$$

Proof: Step 1: We show (4). Let $\left\{u_{1}, \ldots, u_{k}\right\} \subseteq \mathbb{R}^{m}$ be an orthonormal basis of $\operatorname{ker} G(1)+G(1)^{*}$. By Corollary 2.3, we have

$$
\operatorname{span}\left\{u_{1}, \ldots, u_{k}\right\}=\operatorname{ker} G(\lambda)+G(\lambda)^{*} \quad \text { for all } \lambda \in \mathbb{C}_{+}
$$

Let $p=m-k$ and extend $\left\{u_{1}, \ldots, u_{k}\right\}$ by $\left\{v_{1}, \ldots, v_{p}\right\}$ to an orthonormal basis of $\mathbb{R}^{m}$, and set

$$
U=\left[\begin{array}{llllll}
v_{1} & \ldots & v_{p} & u_{1} & \ldots & u_{k}
\end{array}\right] .
$$

By Proposition 2.2, we have that $G(s) u_{i}$ is constant for all $i \in\{1, \ldots, m\}$. Since $G(s)^{\top}$ is positive real as well, we further obtain that $G(s)^{\top} u_{i}$ is constant for all $i \in\{1, \ldots, m\}$. Consequently, $U^{\top} G(s) U$ is of the form

$$
U^{\top} G(s) U=\left[\begin{array}{cc}
G_{1}(s) & L_{12} \\
L_{21} & L_{22}
\end{array}\right] .
$$

Step 2: We show the properties of the blocks in (4). By construction of $U$, we have, for all $\lambda \in \mathbb{C}_{+}$,

$$
\begin{aligned}
& {\left[\begin{array}{ll}

\end{array}\right]=U^{\top}\left(G(\lambda)+G(\lambda)^{*}\right) U } \\
= & U^{\top} G(\lambda) U+\left(U^{\top} G(\lambda) U\right)^{*}=\left[\begin{array}{cc}
G_{1}(\lambda)+G_{1}(\lambda)^{*} & L_{12}+L_{21}^{\top} \\
L_{21}+L_{12}^{\top} & L_{22}+L_{22}^{\top}
\end{array}\right],
\end{aligned}
$$

Hence, we obtain that $L_{22}$ is skew-symmetric and $L_{12}=$ $-L_{21}^{\top}$. Assuming that $w \in \mathbb{C}^{p} \backslash\{0\}$ is such that $\left(G_{1}(\lambda)+\right.$ $\left.G_{1}(\lambda)^{*}\right) w=0$ implies that $\left(G(\lambda)+G(\lambda)^{*}\right) u=0$ for $u:=$ $U\left(w^{\top}, 0\right)^{\top}$. Therefore,

$$
u \in \operatorname{ker} G(\lambda)+G(\lambda)^{*}=\operatorname{span}\left\{u_{1}, \ldots, u_{k}\right\}=\operatorname{im} U\left[\begin{array}{l}
0 \\
I_{k}
\end{array}\right],
$$

which yields $u=0$ and hence $w=0$, a contradiction.
Step 3: It remains to prove (5). The inclusion " $\subseteq$ " is obvious. To show " $\supseteq$ ", assume that $u \in \operatorname{ker} G(1)$. Then $u^{*}\left(G(1)+G(1)^{*}\right) u=0$ and, by semi-definiteness of $G(1)$, we have $\left(G(1)+G(1)^{*}\right) u=0$. Partitioning

$$
\left[\begin{array}{l}
u^{1} \\
u^{2}
\end{array}\right]=U^{\top} u
$$

we obtain that $u^{1} \in \operatorname{ker} G_{1}(1)+G_{1}(1)^{*}$ and hence $u_{1}=0$. Consequently

$$
u_{2} \in \operatorname{ker}\left[\begin{array}{l}
L_{12} \\
L_{22}
\end{array}\right]
$$

## III. Reciprocal transfer functions

Passive electrical circuits modelled by the MNA method feature a special symmetry property, that is their transfer matrix is reciprocal. In this section we aim for decomposition of positive real and reciprocal rational matrices. First, we
have a closer look at the representation (3) of a reciprocal matrix.

Theorem 3.1: Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real and reciprocal with signature $\left(m_{1}, m_{2}\right)$. Then the matrices in (3) are of the form

$$
\begin{align*}
M_{0} & =\left[\begin{array}{cc}
M_{0,11} & M_{0,12} \\
-M_{0,12}^{\top} & M_{0,22}
\end{array}\right], \quad M_{1}=\left[\begin{array}{cc}
M_{1,11} & 0 \\
0 & M_{1,22}
\end{array}\right], \\
R_{0} & =\left[\begin{array}{cc}
R_{0,11} & 0 \\
0 & R_{0,22}
\end{array}\right],  \tag{6}\\
R_{j} & =\left[\begin{array}{cc}
R_{j, 11} & i R_{j, 12} \\
-i R_{j, 12}^{\top} & R_{j, 22}
\end{array}\right] \text { for } j \in\{1, \ldots, k\},
\end{align*}
$$

where

$$
\begin{aligned}
-M_{0,11}, M_{1,11}, R_{0,11}, R_{1,11}, \ldots, R_{k, 11} & \in & \mathbb{R}^{m_{1}, m_{1}} & \text { and } \\
M_{0,22}, M_{1,22}, R_{0,22}, R_{1,22}, \ldots, R_{k, 22} & \in & \mathbb{R}^{m_{2}, m_{2}} & \text { are }
\end{aligned}
$$

symmetric and positive semi-definite,

$$
-M_{0,12}, R_{1,12}, \ldots, R_{k, 12} \in \mathbb{R}^{m_{1}, m_{2}} 1
$$

Furthermore, the matrices

$$
\left[\begin{array}{ll}
R_{j, 11} & R_{j, 12}  \tag{7}\\
R_{j, 12}^{\top} & R_{j, 22}
\end{array}\right]
$$

are positive semi-definite for all $j \in\{1, \ldots, k\}$.
Proof: By reciprocity of $G(s)$, we find

$$
M_{1} S=\lim _{\lambda \rightarrow \infty} \frac{1}{\lambda} G(\lambda) S=\lim _{\lambda \rightarrow \infty} \frac{1}{\lambda} S G(\lambda)^{\top}=S M_{1}^{\top}
$$

Together with the symmetry property $M_{1}=M_{1}^{\top}$, we now obtain that this matrix is of the form

$$
M_{1}=\operatorname{diag}\left(M_{1,11}, M_{1,22}\right)
$$

By furthermore using the limit representations

$$
R_{0}=\lim _{\lambda \rightarrow 0} \lambda G(\lambda), \quad R_{j}=\lim _{\lambda \rightarrow i \omega_{j}}\left(\lambda-i \omega_{j}\right) G(\lambda)
$$

we can infer from the reciprocity of $G(s)$ that

$$
\begin{aligned}
& R_{0} S=S R_{0}^{\top} \\
\text { and } & R_{j} S=S R_{j}^{\top} \text { for all } j \in\{1, \ldots, k\} .
\end{aligned}
$$

Hence, $R_{0}$ has a block diagonal structure by the same reason as for $M_{1}$. We can furthermore apply this argumentation to the symmetric and positive semi-definite matrices $\operatorname{Re}\left(R_{1}\right), \ldots, \operatorname{Re}\left(R_{k}\right)$ to see that they are of a block diagonal structure. On the other hand the imaginary parts $\operatorname{Im}\left(R_{1}\right), \ldots, \operatorname{Im}\left(R_{k}\right)$ are skew-symmetric and reciprocal with signature $\left(m_{1}, m_{2}\right)$. This implies that $\operatorname{Im}\left(R_{j}\right)$ has a block structure

$$
\operatorname{Im}\left(R_{j}\right)=\left[\begin{array}{cc}
0 & R_{j, 12} \\
-R_{j, 12}^{\top} & 0
\end{array}\right] \text { for } j \in\{1, \ldots, k\}
$$

where $R_{1,12}, \ldots, R_{k, 12} \in \mathbb{R}^{m_{1}, m_{2}}$.
To verify the block structure of $M_{0}$, observe that by Lemma 2.1 the matrix $M_{0}+M_{0}^{\top}$ is positive semi-definite. Furthermore,

$$
M_{0}=\lim _{\lambda \rightarrow \infty}\left(G(\lambda)-\lambda M_{1}\right)
$$

hence, using $M_{1} S=S M_{1}^{\top}$, we find $M_{0} S=S M_{0}^{\top}$.
It remains to show that (7) is positive semi-definite. This follows from

$$
\begin{aligned}
& {\left[\begin{array}{ll}
R_{j, 11} & R_{j, 12} \\
R_{j, 12}^{\top} & R_{j, 22}
\end{array}\right]} \\
& \quad=\left[\begin{array}{cc}
I_{m_{1}} & 0 \\
0 & i I_{m_{2}}
\end{array}\right] \underbrace{\left[\begin{array}{cc}
R_{j, 11} & i R_{j, 12} \\
-i R_{j, 12}^{\top} & R_{j, 22}
\end{array}\right]}_{=R_{j}}\left[\begin{array}{cc}
I_{m_{1}} & 0 \\
0 & i I_{m_{2}}
\end{array}\right]^{*}
\end{aligned}
$$

Since the matrices $M_{1}$ and $R_{0}$ vanish outside the diagonal blocks, we can conclude the following.

Corollary 3.2: Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real and reciprocal with signature $\left(m_{1}, m_{2}\right)$ and let $G(s)$ be partitioned as in (2). Then the rational function $G_{12}(s)$ is proper and has no pole at zero.

If $G(s) \in \mathbb{R}(s)^{m, m}$ is positive real and reciprocal with signature $\left(m_{1}, m_{2}\right)$, then the functions $G_{11}(s) \in \mathbb{R}(s)^{m_{1}, m_{1}}$, $G_{22}(s) \in \mathbb{R}(s)^{m_{2}, m_{2}}$ are both symmetric and positive real. By Proposition 2.2, the latter property implies that the kernels of $G_{11}(\lambda)$ and $G_{22}(\lambda)$ are independent of $\lambda \in \mathbb{C}_{+}$. In the following result, we show that $G_{12}^{\top}(s)$ and $G_{12}(s)$ are constant on these kernels.

Proposition 3.3: Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real and reciprocal with signature ( $m_{1}, m_{2}$ ) and let $G(s)$ be partitioned as in (2). If $u_{1} \in \mathbb{R}^{m}$ is such that $u_{1}^{\top} G_{11}(s) u_{1}=0$, then $G_{11}(s) u_{1}=0$ and $G_{12}(s)^{\top} u_{1}$ is constant. If $u_{2} \in \mathbb{R}^{m}$ is such that $u_{2}^{\top} G_{22}(s) u_{2}=0$, then $G_{22}(s) u_{2}=0$ and $G_{12}(s) u_{2}$ is constant.

Proof: By Theorem 2.4, there exists some orthogonal matrix $U_{1} \in \mathbb{R}^{m_{1}, m_{1}}$, such that

$$
U_{1}^{\top} G_{11}(s) U_{1}=\left[\begin{array}{cc}
H_{11}(s) & L_{12} \\
-L_{12}^{\top} & L_{22}
\end{array}\right]
$$

where $H_{11}(s) \in \mathbb{R}(s)^{p_{1}, p_{1}}$ has the property that $H_{11}(\lambda)+$ $H_{11}(\lambda)^{*}$ is positive definite for all $\lambda \in \mathbb{C}_{+}$, and $L_{12} \in$ $\mathbb{R}^{p_{1}, m_{1}-p_{1}}, L_{22} \in \mathbb{R}^{m_{1}-p_{1}, m_{1}-p_{1}}$ is such that $L_{22}^{\top}=-L_{22}$. The symmetry of $G_{11}(s)$ now implies that $L_{12}=0$ and $L_{22}=0$. Assuming that $u_{1}^{\top} G(s) u_{1}=0$, we obtain from the above matrix decomposition that

$$
u_{1}=U_{1}\left[\begin{array}{c}
0 \\
u_{12}
\end{array}\right]
$$

for some $u_{12} \in \mathbb{R}^{p_{1}-m_{1}}$. Consequently, we obtain

$$
G_{11}(s) u=U_{1}\left[\begin{array}{cc}
H_{11}(s) & 0 \\
0 & 0
\end{array}\right]\left[\begin{array}{c}
0 \\
u_{12}
\end{array}\right]=0
$$

It remains to show that $G_{12}(s)^{\top} u_{1}$ is constant: By defining $u=\left(u_{1}^{\top}, 0\right)^{\top}$, we have

$$
u^{\top} G(s) u=u_{1}^{\top} G_{11}(s) u_{1}=0
$$

By Proposition 2.2, we obtain the desired result from

$$
G(s) u=\left[\begin{array}{c}
0 \\
-G_{12}(s)^{\top} u_{1}
\end{array}\right]
$$

The proof of the last statement is analogous.

As a consequence of Proposition 3.3, we can infer that a positive real and reciprocal rational matrix admits a certain form under similarity transform with orthogonal matrices.

Theorem 3.4: Let $G(s) \in \mathbb{R}(s)^{m, m}$ be positive real and reciprocal with signature $\left(m_{1}, m_{2}\right)$. Then there exist numbers and matrices
$-p_{1} \in\left\{0, \ldots, m_{1}\right\}, p_{2} \in\left\{0, \ldots, m_{2}\right\}$,

- orthogonal $U_{1} \in \mathbb{R}^{m_{1}, m_{1}}, U_{2} \in \mathbb{R}^{m_{2}, m_{2}}$,
- positive real and symmetric $H_{11}(s) \in \mathbb{R}(s)^{p_{1}, p_{1}}, H_{33}(s) \in$ $\mathbb{R}(s)^{p_{2}, p_{2}}$ such that $H_{11}(\lambda)+H_{11}(\lambda)^{*}>0$ and $H_{33}(\lambda)+$ $H_{33}(\lambda)^{*}>0$ for all $\lambda \in \mathbb{C}_{+}$,
- $L_{14} \in \mathbb{R}^{p_{1}, m_{2}-p_{2}}, L_{23} \in \mathbb{R}^{m_{1}-p_{1}, p_{2}}, L_{24} \in \mathbb{R}^{m_{1}-p_{1}, m_{2}-p_{2}}$,
such that, for $U=\operatorname{diag}\left(U_{1}, U_{2}\right)$, it holds

$$

Furthermore, for all $\lambda \in \mathbb{C}_{+}$, we have

Proof: Step 1: We show the form (8). Let $\left\{u_{11}, \ldots, u_{k 1}\right\} \subseteq \mathbb{R}^{m_{1}},\left\{u_{12}, \ldots, u_{l 2}\right\} \subseteq \mathbb{R}^{m_{2}}$ be orthonormal bases of $\operatorname{ker} G_{11}(1)+G_{11}(1)^{*}$ and $\operatorname{ker} G_{22}(1)+G_{22}(1)^{*}$, resp. We can infer from Proposition 3.3, that for all $\lambda \in \mathbb{C}_{+}$

Let $p_{1}=m_{1}-k, p_{2}=m_{2}-l$ and extend $\left\{u_{11}, \ldots, u_{k 1}\right\}$ by $\left\{v_{11}, \ldots, v_{p_{1} 1}\right\}$ and $\left\{u_{12}, \ldots, u_{l 2}\right\}$ by $\left\{v_{12}, \ldots, v_{p_{2} 2}\right\}$ to orthonormal bases of $\mathbb{R}^{m_{1}}$ and $\mathbb{R}^{m_{2}}$, resp. Define the orthogonal matrices

By Proposition 3.3, we have that $G_{11}(s) u_{j 1}=0$ and $G_{12}(s)^{\top} u_{j 1}$ is constant for all $j \in\{1, \ldots, k\}$. Analogously, we find that $G_{22}(s) u_{j 2}=0$ and $G_{12}(s)^{\top} u_{j 1}$ is constant for all $j \in\{1, \ldots, k\}$. Consequently, $U^{\top} G(s) U$ is of the form

L_{24} \in \mathbb{R}^{m_{1}-p_{1}, m_{2}-p_{2}}, & L_{32} \in \mathbb{R}^{p_{2}, m_{1}-p_{1}}, \\
L_{41} \in \mathbb{R}^{m_{2}-p_{2}, p_{1}}, & L_{42} \in \mathbb{R}^{m_{2}-p_{2}, m_{1}-p_{1}} .

Reciprocity of $G(s)$ means that $G(s) S=S G(s)^{\top}$. Since $U=$ $\operatorname{diag}\left(U_{1}, U_{2}\right)$, we obtain that $U S=S U$ and $U^{\top} S=S U^{\top}$.

Therefore,

which means that $U^{\top} G(s) U$ is reciprocal with signature ( $m_{1}, m_{2}$ ). This implies

Step 2: We show that $H_{11}(\lambda)+H_{11}(\lambda)^{*}>0$ and $H_{33}(\lambda)+$ $H_{33}(\lambda)^{*}>0$ for all $\lambda \in \mathbb{C}_{+}$. Since $H_{11}(s)$ and $H_{33}(s)$ are positive real, positive semi-definiteness of the aforementioned matrices is clear. Suppose there exists $u_{1} \in \mathbb{C}^{p_{1}} \backslash\{0\}$ such that $u_{1}^{\top}\left(H_{11}(\lambda)+H_{11}(\lambda)^{*}\right) u_{1}=0$. Then $u:=U_{1}\left(u_{1}^{\top}, 0,\right)^{\top}$ satisfies $u^{\top}\left(G_{11}(\lambda)+G_{11}(\lambda)^{*}\right) u=0$, hence

Step 3: It remains to prove (9). The inclusion " $\supseteq$ " is obvious. To show " $\subseteq$ ", let $u \in \operatorname{ker} G(1)$. Then we have $u^{\top}\left(G(1)+G(1)^{\top}\right) u=0$ and, by the semi-definiteness of $G(1)$, we find $\left(G(1)+G(1)^{\top}\right) u=0$. Partitioning

## IV. Transfer functions of electrical circuits

Electrical circuits with linear time-invariant resistances, capacitances and inductances can be modeled by linear differential-algebraic systems of the form

where $E, A \in \mathbb{R}^{n, n}, B, C^{\top} \in \mathbb{R}^{n, m}$.
The functions $u, y: \mathbb{R} \rightarrow \mathbb{R}^{m}$ are called input and output of the system, resp. If the matrix pencil $s E-A \in \mathbb{R}[s]$ is regular (that is, $s E-A \in \mathbf{G I}_{n}(\mathbb{R}(s))$ ), then the frequency domain behavior is described by the transfer function, which is given by

$$

We assume that the input is formed by the currents of current sources and the voltages of voltage sources, and the output is given by the currents of voltage sources together with the voltages of voltage sources. Modified nodal analysis (MNA) [9] leads to

& \mathrm{A}_{\mathcal{R}} \in \mathbb{R}^{n_{e}, n_{\mathcal{G}}}, \mathrm{A}_{\mathcal{L}} \in \mathbb{R}^{n_{e}, n_{\mathcal{L}}}, \mathrm{A}_{\mathcal{V}} \in \mathbb{R}^{n_{e}, m_{\mathcal{V}}}, \mathrm{A}_{\mathscr{I}} \in \mathbb{R}^{n_{e}, m_{\mathscr{I}}}, \\

Here $\mathrm{A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathscr{L}}, \mathrm{A}_{\mathcal{V}}$ and $\mathrm{A}_{\mathscr{I}}$ denote the element-related incidence matrices, $\mathcal{C}, \mathcal{G}$ and $\mathcal{L}$ are the matrices expressing the consecutive relations of capacitances, resistances and inductances, $\eta(t)$ is the vector of node potentials, $i_{\mathcal{L}}(t), i_{V}(t)$, $i_{\mathscr{I}}(t)$ are the vectors of currents through inductances, voltage and current sources, and $v_{\mathcal{V}}(t), v_{\mathscr{I}}(t)$ are the voltages of voltage and current sources.

We assume that the given circuit is connected and passive, which is guaranteed by the assumptions

Note that regularity of $s E-A$ is equivalent to

This is equivalent to the absence of loops of voltage sources and cutsets of current sources (basically, this means that the circuit does not contain any short circuits) [10], [11]. The rational function $G(s)=C(s E-A)^{-1} B$ is moreover
positive real and reciprocal with signature ( $m_{\mathscr{I}}, m_{\mathcal{V}}$ ) [5]. Consequently, the overall transfer function has the form

Let $Z_{\mathcal{V}}$ be a matrix with full column rank and $\operatorname{im} Z_{\mathcal{V}}=$ $\operatorname{ker} \mathrm{A}_{V}^{\top}$. Then the equation

Using that $H_{C \mathcal{R L}}(s)$ is positive real, we can apply Corollary 2.3 to see that $Z_{\mathcal{V}}^{\top} H_{\mathcal{C} \mathcal{L}}(\lambda) Z_{\mathcal{V}}$ is invertible for all $\lambda \in \mathbb{C}_{+}$. Therefore, we obtain

Since its inverse is reciprocal with signature $\left(n_{e}, m_{\mathcal{V}}\right)$, the rational matrix $X(s)$ has this property, too. Thus we have

Consequently, the transfer function in (16) is given by

& H_{33}(s)=\bar{Z}_{\mathscr{I}-\mathcal{V}}^{\top} \mathrm{A}_{\mathscr{I}}^{\top}\left(\mathrm{A}_{\mathcal{V}}^{\top} \mathrm{A}_{\mathcal{V}}\right)^{-1} \mathrm{~A}_{\mathcal{V}}^{\top} H_{\mathcal{C R}}(s) \\
& \cdot\left(I-Z_{V}\left(Z_{V}^{\top} H_{\text {CRL }}(s) Z_{V}\right)^{-1} Z_{V}^{\top} H_{\text {CRL }}(s)\right) \\
& \text { - } \mathrm{A}_{\mathcal{V}}\left(\mathrm{A}_{\mathcal{V}}^{\top} \mathrm{A}_{\mathcal{V}}\right)^{-1} \bar{Z}_{\mathcal{V}-c \mathcal{R L}} \text {. }
\end{aligned}
$$

We finally give an expression for the kernels of the circuit transfer function.

Proposition 4.2: Let $[E, A, B, C]$ as in (11) be given such that (A1), (A2), (14) and (15) hold. Then the rational function $G(s)=C(s E-A)^{-1} B \in \mathbb{R}(s)^{m, m}$ satisfies, for all $\lambda \in \mathbb{C}_{+}$,

$$
\operatorname{ker} G(\lambda)=\operatorname{ker} \mathrm{A}_{\mathscr{I}} \times\left(\mathrm{A}_{\mathcal{V}}^{\top} \cdot \operatorname{ker}\left[\mathrm{A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathscr{L}}, \mathrm{A}_{\mathscr{I}}\right]^{\top}\right)
$$

Proof: Using (9) and the above expressions for $L_{14}$, $L_{23}$ and $L_{24}$, it suffices to prove that

$$
\begin{align*}
& \left\{x \in \operatorname{ker} Z_{\mathcal{V}}^{\top} \mathrm{A}_{\mathscr{I}} \mid\left(\mathrm{A}_{\mathcal{V}}^{\top} \mathrm{A}_{\mathcal{V}}\right)^{-1} \mathrm{~A}_{\mathcal{V}}^{\top} \mathrm{A}_{\mathscr{I}} x=0\right\}  \tag{i}\\
= & \operatorname{ker} \mathrm{A}_{\mathscr{I}},
\end{align*}
$$

(ii)

$$
\begin{aligned}
& \quad\left\{x \in \operatorname{ker}\left[\mathrm{~A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathcal{L}}\right]^{\top} \mid \mathrm{A}_{\mathscr{I}}^{\top}\left(\mathrm{A}_{\mathcal{C}} \mathrm{A}_{\mathcal{C}}^{\top}+\mathrm{A}_{\mathcal{R}} \mathrm{A}_{\mathcal{R}}^{\top}\right.\right. \\
& \left.\left.\quad+\mathrm{A}_{\mathcal{L}} \mathrm{A}_{\mathcal{L}}^{\top}+\mathrm{A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top}\right)^{-1} A_{\mathcal{V}} A_{\mathcal{V}}^{\top} x=0\right\} . \\
& =\operatorname{ker}\left[\mathrm{A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathcal{L}}, \mathrm{A}_{\mathscr{I}}\right]^{\top} .
\end{aligned}
$$

(i) The inclusion " $\subseteq$ " follows from invertibility of $\left[\begin{array}{c}\left(\mathrm{A}_{\mathcal{V}}^{\top} \mathrm{A}_{\mathcal{V}}\right)^{-1} \mathrm{~A}_{\mathcal{V}}^{\top} \\ Z_{\mathcal{V}}^{\top}\end{array}\right]$. The converse inclusion is obvious.
(ii) To prove " $\subseteq$ ", let $x \in \operatorname{ker}\left[\mathrm{~A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathcal{L}}\right]^{\top}$ satisfy

$$
\mathrm{A}_{\mathscr{J}}^{\top}\left(\mathrm{A}_{\mathcal{C}} \mathrm{A}_{\mathcal{C}}^{\top}+\mathrm{A}_{\mathcal{R}} \mathrm{A}_{\mathcal{R}}^{\top}+\mathrm{A}_{\mathcal{L}} \mathrm{A}_{\mathcal{L}}^{\top}+\mathrm{A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top}\right)^{-1} \mathrm{~A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top} x=0
$$

Then

$$
\begin{aligned}
0= & \mathrm{A}_{\mathscr{I}}^{\top}\left(\mathrm{A}_{\mathcal{C}} \mathrm{A}_{\mathcal{C}}^{\top}+\mathrm{A}_{\mathcal{R}} \mathrm{A}_{\mathcal{R}}^{\top}+\mathrm{A}_{\mathcal{L}} \mathrm{A}_{\mathcal{L}}^{\top}+\mathrm{A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top}\right)^{-1} \\
& \cdot\left(\mathrm{~A}_{\mathcal{C}} \mathbf{A}_{\mathcal{C}}^{\top}+\mathrm{A}_{\mathcal{R}} \mathrm{A}_{\mathcal{R}}^{\top}+\mathrm{A}_{\mathcal{L}} \mathrm{A}_{\mathcal{L}}^{\top}+\mathrm{A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top}\right) x \\
= & \mathrm{A}_{\mathscr{J}}^{\top} x,
\end{aligned}
$$

and thus $x \in \operatorname{ker}\left[\mathrm{~A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathcal{L}}, \mathrm{A}_{\mathscr{I}}\right]^{\top}$.
Assuming conversely that $x \in \operatorname{ker}\left[\mathrm{~A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathcal{L}}, \mathrm{A}_{\mathscr{I}}\right]^{\top}$, we clearly have $x \in \operatorname{ker}\left[\mathrm{~A}_{\mathcal{C}}, \mathrm{A}_{\mathcal{R}}, \mathrm{A}_{\mathcal{L}}\right]^{\top}$, and further

$$
\begin{aligned}
& \mathrm{A}_{\mathscr{I}}^{\top}\left(\mathrm{A}_{\mathcal{C}} \mathrm{A}_{\mathcal{C}}^{\top}+\mathrm{A}_{\mathcal{R}} \mathrm{A}_{\mathcal{R}}^{\top}+\mathrm{A}_{\mathcal{L}} \mathrm{A}_{\mathcal{L}}^{\top}+\mathrm{A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top}\right)^{-1} \mathrm{~A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top} x \\
= & \mathrm{A}_{\mathscr{I}}^{\top}\left(\mathrm{A}_{\mathcal{C}} \mathrm{A}_{\mathcal{C}}^{\top}+\mathrm{A}_{\mathcal{R}} \mathrm{A}_{\mathcal{R}}^{\top}+\mathrm{A}_{\mathcal{L}} \mathrm{A}_{\mathcal{L}}^{\top}+\mathrm{A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top}\right)^{-1} \\
& \cdot\left(\mathrm{~A}_{\mathcal{C}} \mathrm{A}_{\mathcal{C}}^{\top}+\mathrm{A}_{\mathcal{R}} \mathrm{A}_{\mathcal{R}}^{\top}+\mathrm{A}_{\mathcal{L}} \mathrm{A}_{\mathscr{L}}^{\top}+\mathrm{A}_{\mathcal{V}} \mathrm{A}_{\mathcal{V}}^{\top}\right) x \\
= & \mathrm{A}_{\mathscr{I}}^{\top} x=0 .
\end{aligned}
$$
